Essential Duties and Responsibilities

Brand management.

- Ensure all products adhere to standards, tone and style.
- Innovate displays of information and research to engage our key stakeholders in new ways.
- Ensure print and web products are accessible and inclusive.

Project management.

- Manage design and web projects from concept to completion.
- Create production timelines that incorporate necessary process steps and colleagues.
- Meet production and publication deadlines.



People management.

- Supervise and support the professional development of the graphic designer.
- Facilitate web-based projects with an external firm.
- Manage external designers, when needed.

Graphic design.

- Create and maintain templates (for reports, PPTs and more) to ensure consistency in branding across materials.
- Collaborate with authors of policy reports and other materials to execute the author/organization's vision and target the intended audiences.
- Create PowerPoint presentations for the Executive Office and polish PPTs for staff members who are speaking at external events, like webinars, conferences and other engagements.
- Create visuals for all ECS events, in person and virtual, including website graphics, promotional graphics, signage, PPTs and email signatures.
- Create graphics for and assist with maintaining ecs.org and ednote.ecs.org.
- Write specifications and solicit bids for ECS printing needs, including ordering and proofing.
- Monitor trends in graphic design tools, applications and strategy.
