A Policy Researcher at Education Commission of the States is an entry-level position that contributes to the organization's mission to provide a wide range of education stakeholders with unbiased information and opportunities for collaboration. As part of the Policy Team the policy researcher performs research tasks that critically support ECS' constituents.

#### **Essential Duties and Responsibilities**

- 1. Under tight deadlines and with review from senior staff, research and respond to requests for information on a wide range of education issues.
- 2. With support and supervision, locate, correctly interpret, and accurately summarize state policies, legislation, statutes and administrative code. Identify state policies to serve as models for policymakers.
- 3. With support and supervision, populate and update 50-state comparisons and databases to reflect current education policy.
- 4. Read and interpret education research and accurately synthesize key findings and policy recommendations for a non-academic audience.
- 5. Write and review reports, blogs, and other policy materials for publication and web distribution on a variety of topics.



- 6. Support ECS events, by generating topic areas and structures, identifying and communicating with speakers, preparing necessary written materials, meeting deadlines, and providing on-site support such as note-taking and time-keeping when applicable.
- 7. Represent Education Commission of the States at national and regional meetings and conferences, as needed. Participate in internal meetings.
- 8. Perform other ECS duties as required.

#### **Required Skills and Qualifications**

- Bachelor's degree preferred.
- 0-3 years of public policy experience preferred.
- Proficient in use of digital software and technology, including databases, Microsoft Word, Excel and PowerPoint.
