Do teachers in a charter school have to be certified?

At the present time, 39 states, the District of Columbia and Puerto Rico have enacted charter school laws, so this database contains information only for them. It does not contain any information for the 11 states that have not enacted charter school laws.

Do teachers in a charter school have to be certified?		
Alaska	Yes	
Arizona	No	
Arkansas	Yes, unless a waiver is granted in the charter.	
California	Yes	
Colorado	Yes, unless a waiver is granted in the charter.	
Connecticut	At least 50% of a charter school's teachers must have standard certification. Up to 50% of teachers in a charter school may have alternative certification or temporary certification and be working toward standard certification.	
Delaware	Yes, with exceptions.	
District of Columbia	No

Georgia	A charter school may request a waiver from teacher certification rules and regulations.	
Hawaii	Yes. All teachers must obtain a license from the Hawaii teacher standards board in such form as the standards board determines.	

Idaho	Yes. Although teachers may apply for a waiver or any of the limited certification options as provided by the state board of education.
Illinois	Charter schools may employ non-certified teachers if they have a bachelor's degree, 5 years experience in the area of degree, a passing score on state teacher tests and evidence of professional growth. Mentoring must be provided to uncertified teachers. At least 50% of the individuals employed in instructional positions by a charter school in Chicago established after April 16, 2003, must hold teaching certificates and 75% of the individuals employed in instructional positions by a charter school in Chicago established before April 16, 2003, must hold teaching certificates.
Indiana	Teachers must either be certified or be in the process of obtaining a license to teach through the transition to teaching program. For those teachers in the transition to teaching program, licenses must be obtained within 3 years of beginning to teach at a charter school.

Louisiana	For most types of charter schools, up to 25% of a charter school's teachers may be non-certified if they meet other specific requirements. For low-performing schools that are converted to charter schools as part of the state's accountability system, beginning no later than the 3rd year of operation, teachers in core subjects must be certified and teachers in other subjects may be non-certified if they meet other specific requirements.
Maryland	Yes
Massachusetts	For Horace Mann charter schools, yes. For commonwealth charter schools, no teacher shall be hired who is not certified unless the teacher has successfully passed the state teacher test.
Michigan	Yes. Except as otherwise provided by law; special exemptions are made for a charter school operated by a state college or university that may wish to use collegiate staff to teach charter school students.

Missouri	Up to 20% of full-time equivalent instructional staff may be filled by non-certified personnel.

New Hampshire At least 50% of a charter school, up to 50% of instructional staff may be non-licensed personnel. Utah	A charter school must employ teachers who are either licensed or would qualify to teach under alternative certification or authorization programs, based on demonstrated competency.

Wisconsin	Yes. However, if a search for licensed teachers is unsuccessful, a special charter school permit is available for persons with a bachelor's degree in their field who take 6 credits of training each year and are supervised by a teacher with a regular license.
