



## **Arkansas State Profile**

State profiles for the data visualization and 50-State Comparison on postsecondary governance structures summarize information about coordinating boards/agencies and governing boards, administrative/service agencies, advisory groups and membership organizations. The most in-depth information is provided for statewide and major postsecondary systemwide coordinating boards/agencies and governing boards.

*Note:* This resource does not include information related to setting tuition rates, administering funding formulas or allocating funds. The state profile information is based primarily on statutes, codes and state and postsecondary system board/agency policies. To the extent possible, Education Commission of the States reached out to state and system officials to verify our information.

## **State Overview**

The Arkansas Higher Education Coordinating Board is a statewide coordinating board for public postsecondary education. The Arkansas Department of Higher Education is the administrative agency charged with carrying out the board's policies and overseeing federal, academic and student financial aid programs, conducting research and analysis, collecting and disseminating data, and publishing higher education reports. The department's executive director is appointed by the coordinating board with input from the Presidents Council and confirmed by the governor. Individual boards govern Arkansas State University, the University of Arkansas and other institutions.
