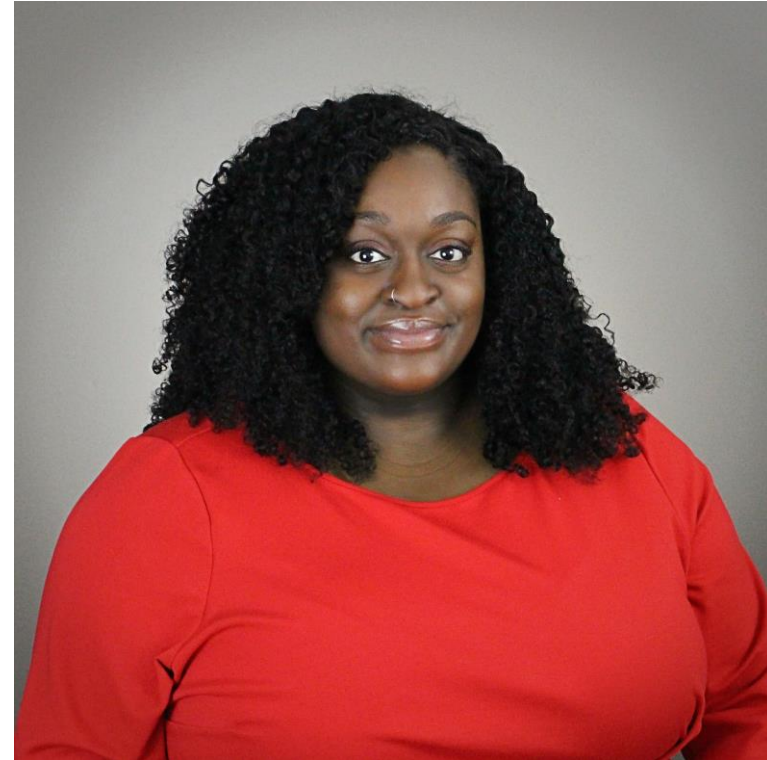

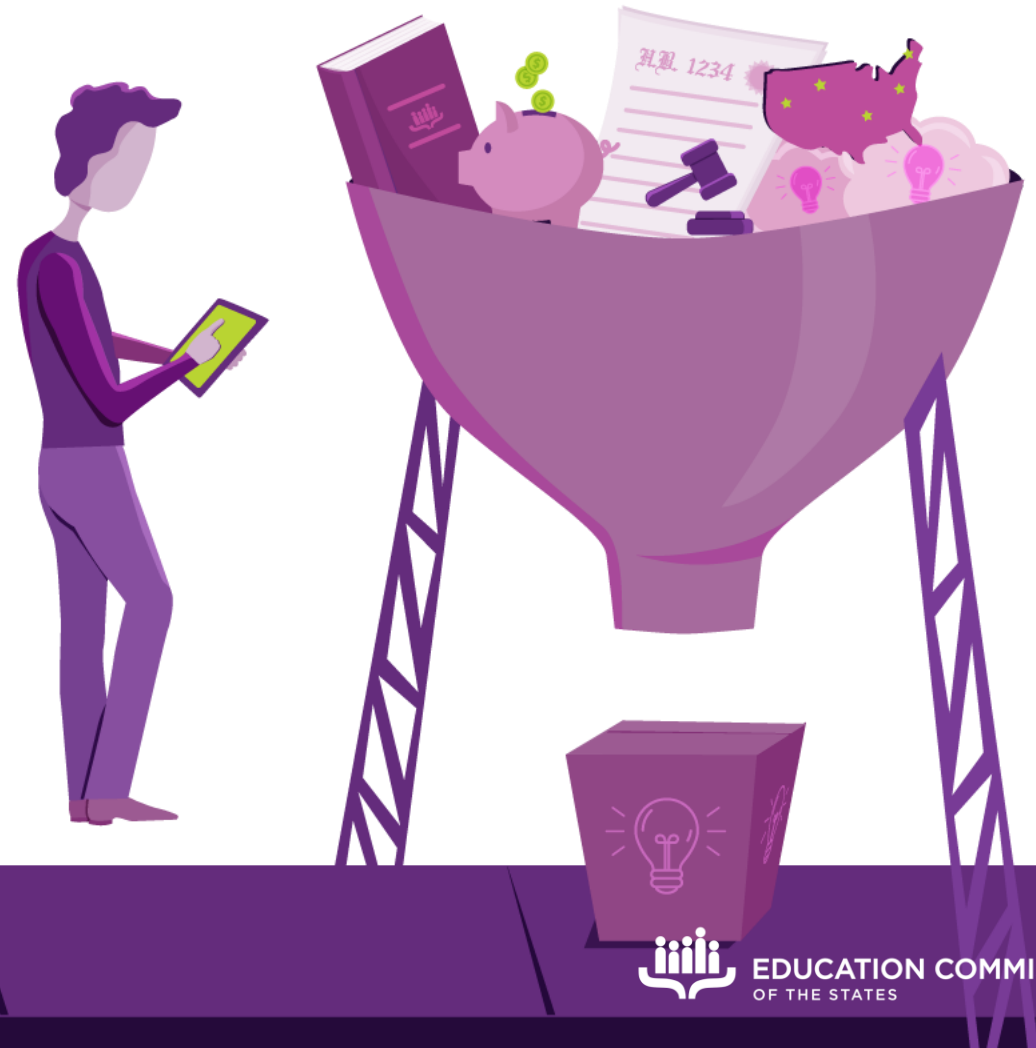

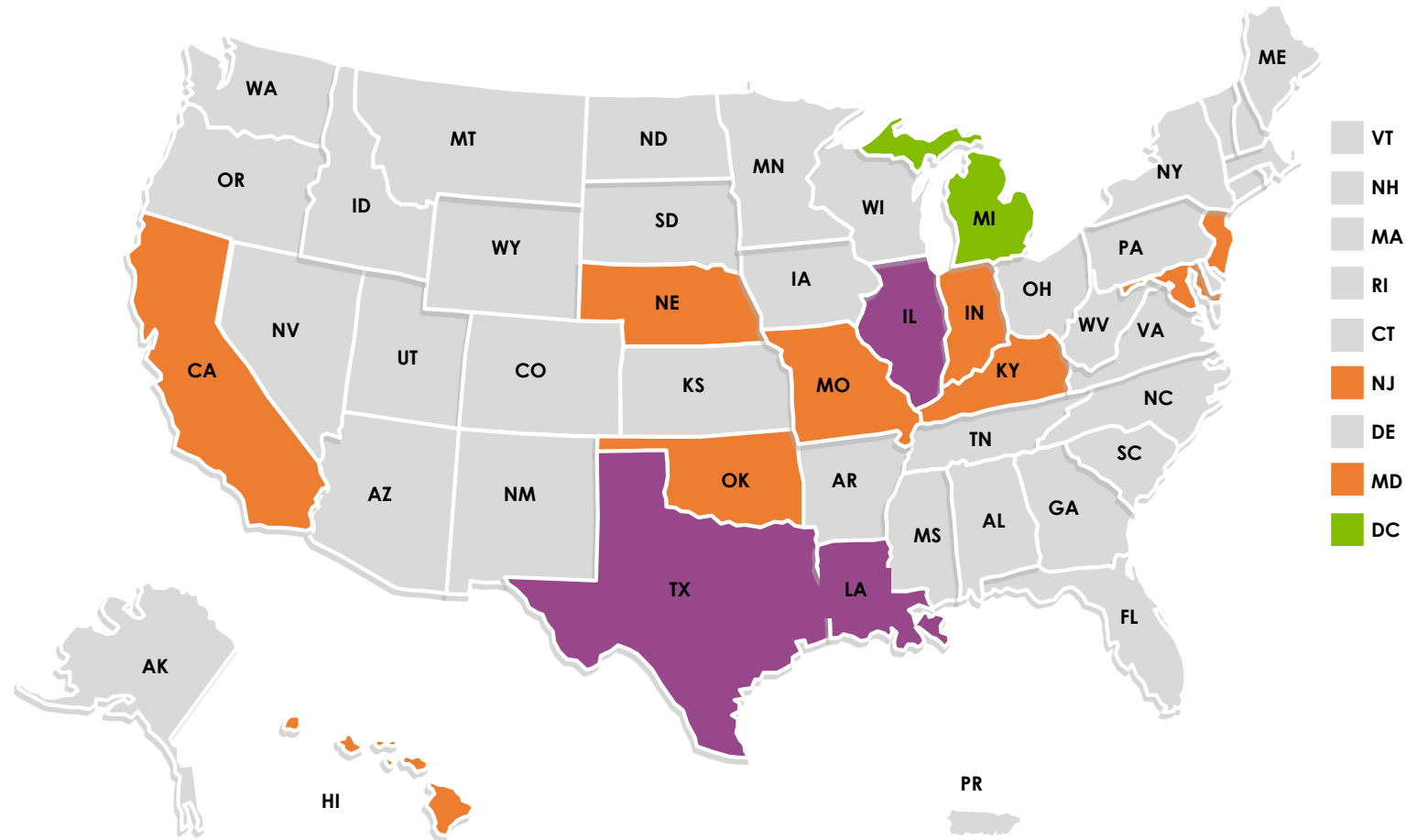

Policy Trends

- Governance
 - Should the requirement apply to all types of high schools?
 - Who has authority to write regulations, if anyone?
 - Who gets to decide what type(s) of students can opt out?
 - Who implements the waiver process?
 - Should data reporting be mandated? To whom? What data?

Policy Trends

- Waivers/Opt-outs
 - Who can waive the policy:
 - Parents
 - Students themselves if over 18
 - Students who are emancipated minors
 - Superintendents, School Boards, Districts, Principals, Counselors
 - Under what conditions can they waive the requirement?

Who leads the change?

In order to provide even greater access to financial aid for Louisiana's students, the Louisiana Department of Education (LDOE) formed the financial aid working group to evaluate the state's financial aid application completion rates, identify deficiencies and solutions for communities with low completion rates, and provide a comprehensive list of recommendations to the LDOE on how to improve financial aid completion rates statewide. The financial aid working group continues to meet quarterly to analyze current trends and best practices in financial aid planning and create a network of resources for students around the state.

How was Louisiana's financial aid access policy developed?

Financial Aid Working Group

- To ensure that parents, students, and school systems have a forum to provide feedback on financial aid access and supports, the Department organized the [Financial Aid Working Group PDF](#) – a diverse group of stakeholders with an interest in increasing access to postsecondary education for Louisiana students.
- The group developed a state action plan, [recommended PDF](#) policy changes, identified support services and programs, assisted the Department in the development of partnerships and alliances with various stakeholders, and presented a [final report PDF](#). The group also publishes the annual [State of Financial Aid in Louisiana PDF](#).

How do you fulfill the Louisiana Financial Aid Access Policy?

Louisiana requires public school students to take one of the following steps:

- [Submit the FAFSA](#);
- Apply for [TOPS](#) with the TOPS online application;
- Submit an opt-out [non-participation form PDF](#) or [letter](#); or
- Receive a [waiver PDF](#) through the school system.

Beginning with 2017-2018 school year, each graduating high school senior in a Louisiana public high school will be required, as part of his individual graduation plan, to complete either the Free Application for Federal Student Aid (FAFSA) or the Taylor Opportunity Program for Students (TOPS) online application, have a parent or legal custodian certify in writing to the student's local education agency (LEA) if he refuses to complete such an application, or the LEA may apply for a waiver of this requirement through the district hardship waiver process.

Beginning with 2017-2018 school year, each graduating high school senior in a Louisiana public high school will be required, as part of his individual graduation plan, to either complete the Free Application for Federal Student Aid (FAFSA), apply for the Taylor Opportunity Program for Students (TOPS) online application, **have a parent or legal custodian submit a written statement of nonparticipation to the local education agency (LEA),** or receive a hardship waiver through the LEA.

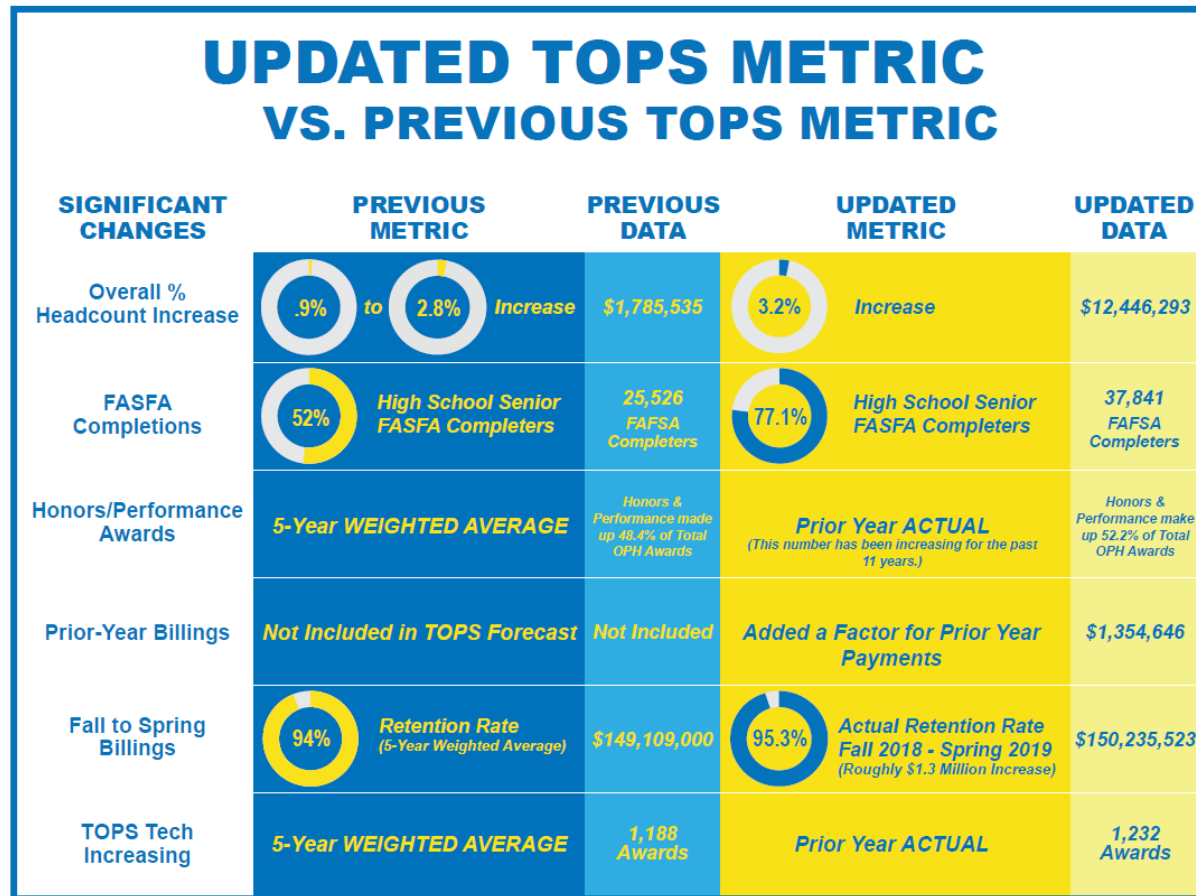

What did the increase in application activity look like after the policy was enacted?

LOSFA Data

- TOPS Online Applications (school year)
 - 2017- 2018: 334 applications
 - 2018-2019: 366 applications
 - 2019-2020: 302 applications (currently; numbers will continue to increase until June 30,2020)
- FAFSAs Completed (FAFSA cycle)
 - **2017-2018: 30,063 (51.2%) through June 28, 2017**
 - 2018-2019: 37,841 (77.1%) through June 29, 2018 – **year one of mandate**, 25.9 increase in completers
 - 2019-2020: 39,500 (82.6%) through August 23, 2019

What did the increase in application activity look like after the policy was enacted?

STATE SUBMISSION DATA ANALYSIS

The state additionally analyses submission data by subgroup. Below are the results from the two years of policy implementation.

NATIONAL COMPARISONS

The [National College Access Network \(NCAN\)](#) published the national completion rates and rank of all states by percent of growth since the previous year each week during the FAFSA cycle from October until the June 30, 2019 priority deadline. Since the implementation of the policy, Louisiana has finished at number one in the nation for FAFSA completions. NCAN reported that 79 percent of students in Louisiana completed the FAFSA by the June 30 priority deadline.⁴

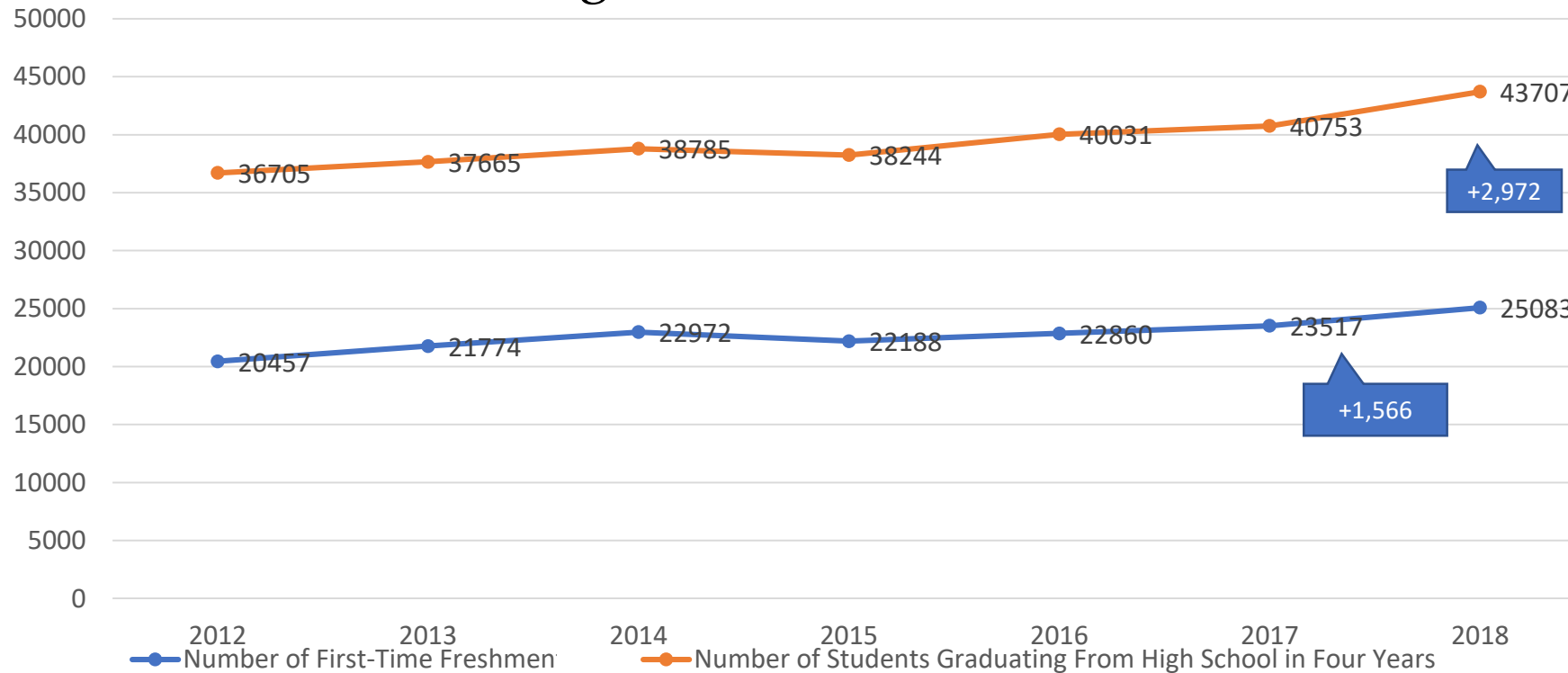

The number of graduates enrolled in the Fall semester immediately following graduation has increased over time, just as the number of students graduating from high school in four years has climbed.

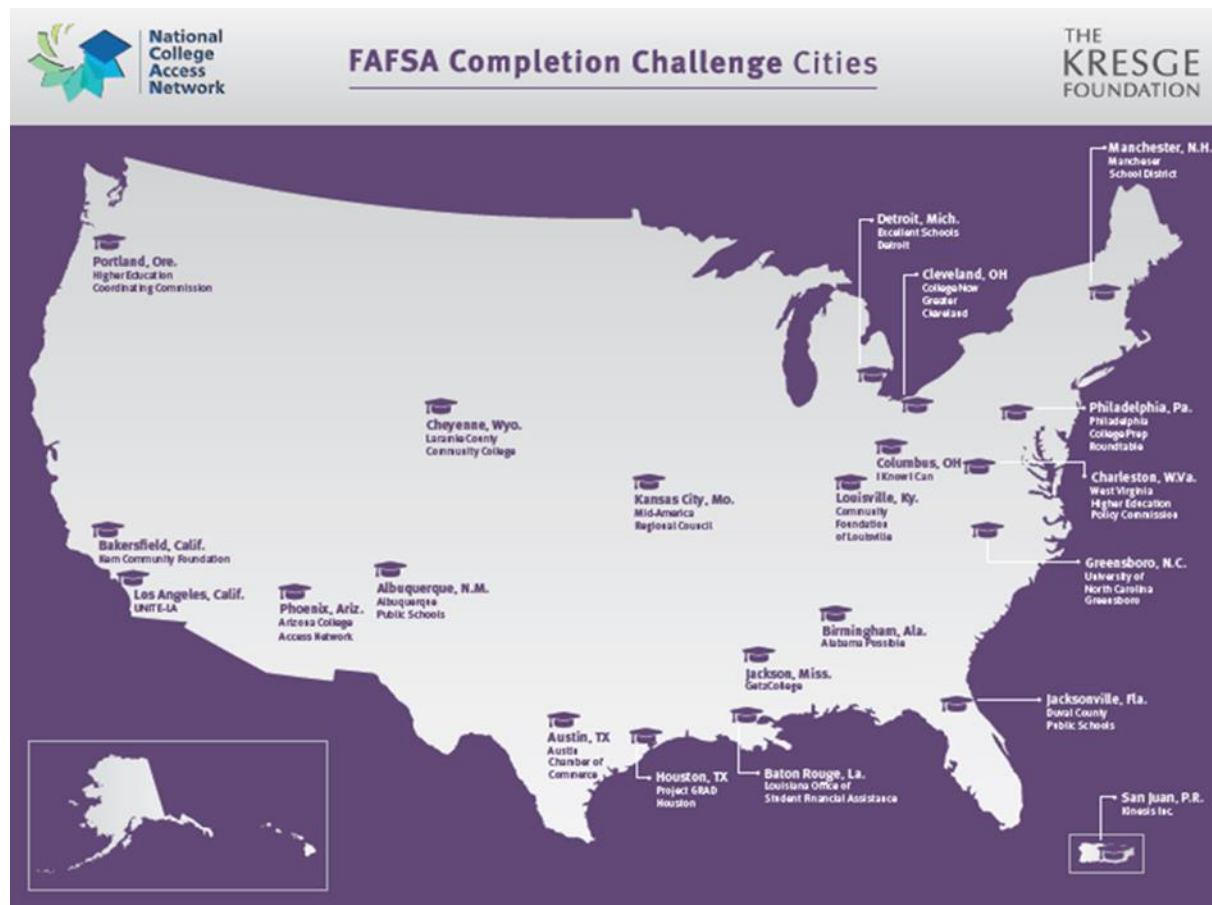

Compete To Complete Pilot

- The Louisiana Office of Student Financial Assistance (LOSFA) received a grant from the **National College Attainment Network (NCAN)** and **The Kresge Foundation** to increase completion of the Free Application for Federal Student Aid (FAFSA) by high school students in 11 East Baton Rouge Parish public schools during the 2016-17 academic year.
- The grant aimed to strengthen the urban postsecondary ecosystems by increasing FAFSA completion rates among high school seniors in East Baton Rouge Parish School System (EBRPSS) by 10 % for the graduating class of 2017 in the “Compete to Complete” support services, sessions, and events.
- During the “Compete to Complete” campaign, LOSFA and its partners utilized creative and reaching promotion strategies, although some events and strategies were less successful due to the flood that affected Baton Rouge and surrounding areas in Louisiana.
- LOSFA and its partners reached their 10 % goal.

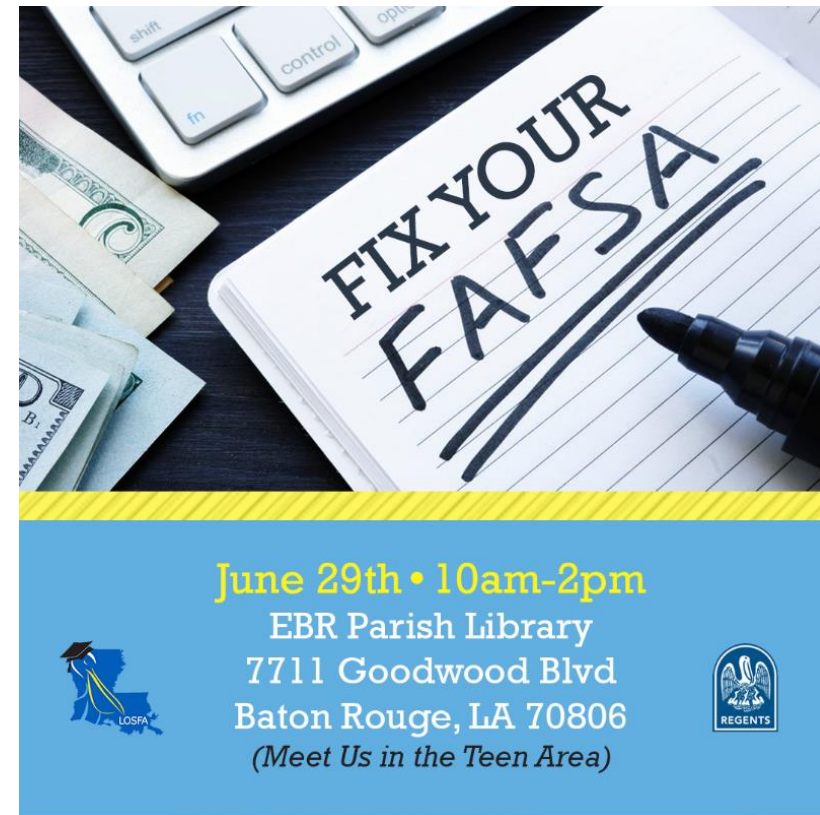
How did we track school performance?

Compete to Complete Portal

- The Office of Federal Student Aid offers data on FAFSA completion at the state, high school, and district levels.
- With that information, LOSFA made its own website portal – [Compete to Complete](#) – where stakeholders could see ranks, in terms of how many students had filled out the FAFSA.
- Louisiana school administrators checked this site often and got excited about their progress, creating friendly competition!
- For NCAN members who may not have the resources to create their own database and website, you can use NCAN's #FormYourFuture FAFSA Tracker. This tracker monitors FAFSA completion at the high school, city, and state levels.

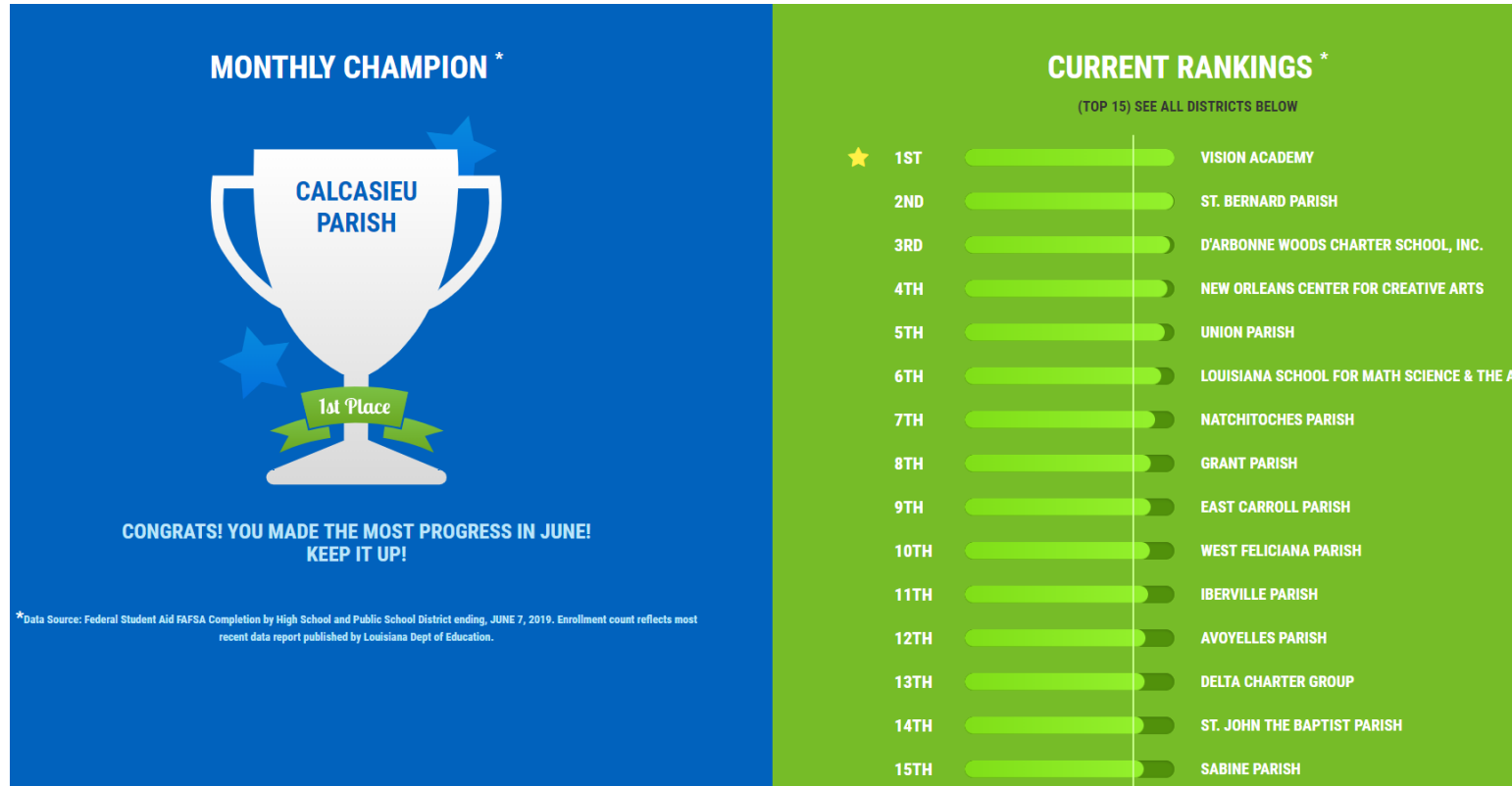
