



Montana State Profile

State profiles for the data visualization and 50-State Comparison on postsecondary governance structures summarize information about coordinating boards/agencies and governing boards, administrative/service agencies, advisory groups and membership organizations. The most in-depth information is provided for statewide and major postsecondary systemwide coordinating boards/agencies and governing boards.

Note: This resource does not include information related to setting tuition rates, administering funding formulas or allocating funds. The state profile information is based primarily on statutes, codes and state and postsecondary system board/agency policies. To the extent possible, Education Commission of the States reached out to state and system officials to verify our information.

State Overview

The Montana Board of Regents for Higher Education serves as the governing board for four- and two-year institutions within the system and as a coordinating board for community colleges. The board appoints the commissioner of higher education. The board's system office administers state and federal programs, conducts policy research, collects and analyzes data, administers student financial aid programs and provides other services to the institutions. While Montana's universities do not have local governing boards, the community colleges are governed by boards.
