## **Your Question:**

Which states have requested waivers of assessment and accountability requirements under the Elementary and Secondary Education Act (ESEA), as amended by the Every Student Succeeds Act (ESSA), and what is the status of those waiver requests?

# **Our Response:**

Below is an overview of state waiver requests for assessment and accountability requirements for the 2020-21 school year. In general, there were <u>four types of waivers requested</u>: assessment, accountability, the 1% cap on using alternative assessments, and for **Maine** and **Montana**, field test waivers.

#### **Assessment Waivers**

At least 12 states and the District of Columbia requested waivers of requirements that the state administer its academic assessments to all public elementary and secondary school students in the state because of the disruptions to education during the COVID-19 pandemic. **Colorado** and **Oregon** proposed alternative administration of assessments and those waivers were approved. Because of the deep impact of the pandemic on the District of Columbia, that waiver request was approved without an alternative plan.

The requirements of the Elementary and Secondary Education Act that were waived are:

- Section 1111(b)(2)(B)(i) requiring the state to administer its academic assessments to all public elementary and secondary school students in the state.
- Section 1111(c)(4)(E) requiring states to measure the achievement of at least 95% of all students and to use test participation as a factor in calculating the achievement indicator in the state's school and district accountability system.

<u>States</u>: California, Colorado, Delaware, District of Columbia, Georgia, Michigan, Montana, New Jersey, New York, Oregon, South Carolina, Washington, Wisconsin.

### **Accountability Waivers**

On Monday, February 22, the U.S. Department of Education issued guidance offering flexibility in state accountability system reporting requirements. The guidance allows states to submit requests to waive accountability, school improvement and school report card requirements for the 2020-21 school year. At least 39 states submitted waiver requests and all of those requests were approved. Those waivers exempt states from the following ESEA requirements:

- Sections 1111(c)(4) and 1111(d)(2)(C)-(D) requiring that a state measure progress toward long-term goals and measurements of interim progress; meaningfully differentiate, on an annual basis, all public schools, including by adjusting the Academic Achievement indicator based on a participation rate below 95%; and identify schools for comprehensive, targeted, and additional targeted support and improvement based on data from the 2020-21 school year.
- Section 1111(h) detailing report card provisions related to accountability based on data from the 2020-21 school year.

In the approval of these waivers, the department stated, "the intent of these accountability waivers is to focus on assessments to provide information to parents, educators, and the public about student performance and to help target resources and supports. This is particularly crucial this year, due to the COVID pandemic. As a result, we also encourage you and your school districts to consider other steps within your purview to further reduce the stakes of assessments this year, such as excluding their use from students' final grades, grade promotion decisions, educator evaluations, and local school ratings. Along with the waivers, states must make certain assurances regarding data sharing and school improvement."

### Waivers of 1% Cap on Alternative Assessments

The ESEA contains requirements for the participation of students with the most significant cognitive disabilities in the assessment aligned with alternate academic achievement standards (AA-AAAS) and caps the total number of students with the most significant cognitive disabilities who are assessed statewide with an AA-AAAS to 1% of the total number of students in the state who are assessed in that subject. At least 18 states requested a waiver of this cap because the prior year data that would need to be used would require more than 1% of students to be assessed using the AA-AAAS. As part of the waiver process, states are required to make certain assurances to receive the waiver. All but one of the waivers was approved. **California's** was denied because they did not meet the 95% assessment benchmark required under ESSA.

<u>States</u>: Alabama, California, Florida, Georgia, Illinois, Indiana, Kentucky, Louisiana, Maryland, Michigan, Nebraska, North Carolina, Ohio, Oklahoma, Texas, Vermont, Virginia and West Virginia.

#### **Field Test Waivers**

Idaho, Maine, Montana and Nebraska had previously received waivers to field test new science assessments. Those were meant to be administered in spring 2020 but were delayed given the COVID-19 pandemic and assessment and accountability waivers issued in 2020. In 2021, Maine and Montana requested waivers to administer those assessments this year and specified how those assessments would be used and reported.
