

Your Question:

1. What is the status of academic standards and teacher certification for dance in each state?
2. What are licensure assessment requirements to become a dance educator in states where dance certification exists?

Our Response:

AEP staff members used information from state education agency websites to update an existing NDEO spreadsheet focused on dance teacher certification and to add information about dance standards. The updated spreadsheet begins on page 2. AEP staff members did not include information about dance certification related to career and technical education, as these programs tend to be available only at the high school level and are usually not aligned to state academic standards. An analysis of the information found the following:

- 1. Every state and the District of Columbia have academic standards for dance.**
 - a. Thirty-six of 51 states have standards aligned to the National Core Arts Standards. Four of those states — **Connecticut, Delaware, New Mexico and Rhode Island** — adopted the standards without changes.
 - b. **Pennsylvania's** arts standards were adopted in 2002, and the state board of education has not released plans to update them. Five states — **Arkansas, Colorado, New Jersey, Oklahoma and Virginia**— most recently adopted arts standards in 2020. **Ohio** has draft standards that are slated for adoption in 2021.
 - c. Of the 41 states that have adopted new standards since the 2014 release of the National Core Arts Standards, five of them — **Colorado, District of Columbia, North Carolina, Virginia and West Virginia** — did not adopt or adapt the NCAS.
- 2. 35 states certify educators in dance.**
 - a. Thirty-one of these states offer full certification as an option, meaning certification is equal to other core content areas.
 - b. In **Colorado, Pennsylvania and Utah**, dance is available as an add-on endorsement to an existing certification.
 - c. In **Kentucky**, dance is available as a restricted base certificate.
- 3. Of the 35 states with dance certification, 12 require a content-specific assessment to obtain licensure.**
 - a. Six of those states — **Arizona, Massachusetts, Minnesota, Ohio, Oklahoma and Washington** — have state-level dance tests. Pearson provides many of these tests.
 - b. Four of the states — **Alabama, Illinois, New Jersey and Tennessee** — require the [edTPA Performing Arts assessment](#).
 - c. **Texas** requires either a state-level test or the edTPA Performing Arts assessment.
 - d. **New York** requires both a state-level test and the edTPA Performing Arts assessment.
