Strategic Funding Alignment to Support Workforce Education Access

This Policy Outline provides an overview of federal funding that supports workforce education.

Workforce education prepares individuals with the knowledge and skills they need to enter and advance in the workforce. The various programs that deliver workforce education are targeted to serve different purposes and different segments of the population by age, income level, demographic group or specific service need. By aligning and coordinating the many different funding streams and programs that deliver workforce education, state policy leaders can develop a strategic and comprehensive approach to ensure that individuals can effectively prepare for jobs today and for the future.

KEY TERMS

Braided funding pools multiple funding streams toward one purpose while separately tracking and reporting on each source of funding.

Blended funding combines, or comingles, multiple funding streams for one purpose without continuing to differentiate or track individual sources.

The chart summarizes the population each program serves (youth, postsecondary students/institutions, and/or adult workers/job seekers) and whether a program's eligibility is restricted to specific populations who typically face additional barriers to employment. Federal funding streams were included if a primary goal of the program is to prepare individuals to enter or advance in the workforce or if a program provides support services that can enhance completion of workforce education. This resource also highlights several block grant programs that include workforce education activities as an allowable use of funds. Block grants give states the flexibility to determine how they use program funds as long as expenditures align with the overall goals of the block grant program.

State leaders play a critical role in coordinating, leveraging, and braiding federal funding streams to deliver efficient and impactful workforce education services. For example, states can create a centralized office or entity that oversees all workforce education activities in the state, to ensure alignment and coordination across funding streams.

ALABAMA created the Governor's Office of Education and Workforce Transformation (GOEWT) to ensure that more individuals have the education and skills they need to participate in the state's workforce. GOEWT's goals are to increase labor force participation, increase postsecondary credential attainment, and create career pathways for youth and adults. To achieve these goals, GOEWT is charged with braiding the state's federal funding for education and workforce development in support of a comprehensive education-to-workforce pipeline. GOEWT staff ensure alignment of the state's secondary and postsecondary CTE, adult education, and workforce development programs and strategic plans; oversee the state's P-20W Council; support registered apprenticeship activities; and more. This office was created in 2019 and its staff report directly to the governor.

established the <u>TalentFOUND</u> talent development network in 2016; it comprises all the state's talent-related systems, partners, programs, and initiatives to ensure that students, job seekers, and workers have access to meaningful careers, and employers have access to skilled talent. TalentFOUND is supported by the Colorado Workforce Development Council and includes partners from secondary education, postsecondary education and training, workforce development, economic development, business, and community-based services. The TalentFOUND website provides one place for students, job seekers, and employers to connect with each other and with tools and resources of the network. In June 2021, TalentFOUND released a guide to braiding and blending funding; the resource provides communities with examples of how they can coordinate and align funds to achieve the greatest impact for the state's residents.
