

## Texas State Profile

November 1, 2020

State profiles for the 50-State Comparison on postsecondary governance structures summarize information about coordinating boards/agencies and governing boards, administrative/service agencies, advisory groups and membership organizations. The most in-depth information is provided for statewide and major postsecondary systemwide coordinating boards/agencies and governing boards.

*Note:* This resource does not include information related to setting tuition rates, administering funding formulas or allocating funds. The state profile information is based primarily on statutes, codes and state and postsecondary system board/agency policies. To the extent possible, Education Commission of the States reached out to state and system officials to verify our information.

### State Overview

The Texas Higher Education Coordinating Board serves as a single statewide coordinating board for public postsecondary education and authorizes and monitors accredited degree-granting private postsecondary institutions. The board appoints the commissioner of higher education. The affiliated agency administers federal and state academic programs, provides data analysis and reports on higher education-related issues, administers student financial aid programs, conducts research and analysis, and determines programs of study, among other responsibilities. Governing boards oversee several four-year postsecondary systems and multi-campus institutions and the Texas State University System, which includes four- and two-year institutions. The community colleges in Texas are not part of a system and are governed by local district boards, and several have multiple campuses. A board of regents oversees the Texas State Technical College System, which operates as a single statewide institution with multiple campuses.
